RULES AND REGULATIONS

- Competitors **must** wear a solid white traditional karate gi
- No jewelry is allowed during competition
- Toenails and fingernails must be trimmed short
- Hand pads, shin and instep pads, mouth piece, groin protector (males) and head gear in all youth divisions is **MANDATORY**
- Shin protector and chest protector (females) are highly recommended
- Only safety glasses with restraining band will be allowed, all other eyewear will not be allowed
- All Kata divisions will be judged using a five judge point system
- Kumite will be judged according to slightly modified USANKF rules
- No contact is permitted to the head, face, neck, joints or groin (except light contact to head in adult black belts only)
- Competitors must provide their own equipment for competition. Some equipment will be available for purchase.

From Boston, MA: (under 50 miles) I-90 West / MASS PIKE / Take EXIT 10A toward RT-146 South / go 4 miles Turn RIGHT onto BOSTON RD just after Tony's Pizza. High School will be on left in about 3 miles.

From New Hampshire: 495 South (follow directions from Boston above)

From Providence, RI: (approximately 30 Miles) I-95 N / Take Exit 23 toward 146 N go 30 miles / Left onto BOSTON RD (first light after Central Turnpike exit). High School will be on left in about 3 miles.

From Hartford, CT: I84 East to I-90 EAST / Take EXIT 10A toward RT-146 South / go 4 miles Turn RIGHT onto BOSTON RD just after Tony's Pizza. High School will be on left in about 3 miles.
